Pedagogy and Demagoguery at Fall Meeting

Aside from the normal conduct of business and opportunity for renewing friendships and acquaintances, the program for the fall meeting will feature a timely selection of presentations: pedagogy, projects, and politics! With the beginning of a new school year and a presidential election looming, what could be more appropriate?

Our first speaker is Dr. Bartolo Natoli, speaking on "Using Project Based Learning in the Latin Classroom: From Theory to Practice." Bart will present the current theory of Project Based Learning (PBL) and research in Second Language Acquisition (SLA) instruction. He will then discuss how he implemented PBL in an undergraduate advanced Latin course at Randolph-Macon College this past fall, a course that culminated in the learner construction of a fully-searchable, online database of text-commentaries on the letters of Marcus Cornelius Fronto.

Dr. Natoli was born in Heidelberg, Germany in 1985. After moving to America, he took his B.A. in Latin, Greek, and Secondary Education from the University of Richmond in 2007. He took his M.Ed. in Adult Education and Training from Colorado State University in 2012. Finally, he took his Ph.D in Classics from the University of Texas at Austin in 2014.



Our second speaker is Ms. Jacquelyn Wilkins, presenting "Mercatus Traiani at the Virginia Governor's Latin Academy." This session will discuss an immersion activity at GLA that focuses on the diversity of the Roman Empire and utilizing conversational Latin.



The 2016 session of GLA marked Jacquelyn's eighth year on staff at the Latin Academy. She was a teacher in 2009, lead teacher from 2010-2014, and this was her second year as director. During the school year, she teaches at William Byrd High and Middle Schools in Roanoke County.

Our final presentation of the day is titled "Demagoguery and Democratic Decay in Athens and Rome," delivered by Dr. Jason Hawke. Both Athens and Rome famously fell to autocratic governments, at the hands of men who were established members of the

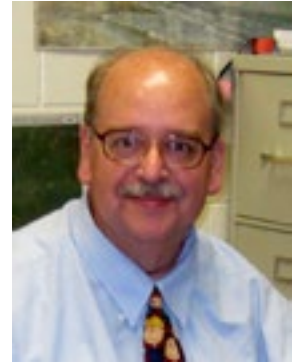

“political class”: in the case of the former, the leaders of the Thirty Tyrants, and in the latter C. Julius Caesar. In each instance, however, unconventional demagogues years before had prepared the ground for these coups by engaging in tactics and rhetoric that undermined popular confidence in institutions, the accepted conventions of political behavior, and the traditional sources of leadership.

Jason Hawke is Associate Professor and Chair of History at Roanoke College, where he teaches the history of the ancient Mediterranean and Latin. He received his Ph.D. in 2000 from the University of Washington.

Be sure to join us in Charlottesville on September 17 for this exciting and relevant collection of papers.

ACL Council Minutes

ACL council convened on Monday, June 27th during the ACL Institute at the University of Texas in Austin. I represented CAV as our organization's delegate and will summarize here the content of the council meeting. After roll call and the approval of the 2015 minutes, ACL President called for reports from executive committee and members. Sue Robertson announced that she finished her term as chair of the Scholarship Committee and that Liz Heimbach was taking over as chair. Deb Heaton (ACL outgoing treasurer) reported on the 2015 audit and presented the 2016 budget. Council approved the 2016 ACL budget after some questions and clarifications about the budget. The full meeting agenda can be found below along with links to pertinent documents.

Then the council discussed old business. I described the constitution revisions that the *ad hoc* Constitution Committee made over the course of this year and directed council members to two documents. The first document contained three columns: the current constitution, the proposed constitution with changes in bold, and notes about the rationale for changes. The second document provided a telescopic view of all changes on one page in three sections: "language changes," "to be discussed," and "for deletion." As expected the "to be discussed" changes were discussed at some length. After many questions and answers, the document was taken to a vote section by section. The first and third sections were approved unanimously and the second section with a few abstentions (due to conflicts of interest) and a couple of nay votes. The main topic of discussion was whether to add the chairs of the NLE, NGE, and ETC to the executive committee. The ACL council voted in favor of this. Another substantive change was to decrease the term of NJCL Executive Committee members to four years instead of five. This had been accepted unanimously by the NJCL Executive Committee at its spring meeting.

ACL President Kathy Elifrits updated the council on the progress of the ACL development project. With the expertise of hired consult Amy Wishnick and under the leadership of the Organizational Development Project Steering Committee (Kathy Elifrits, Sherwin Little, Patrick McFadden, Linda Montross, Amy Sommer) and the Organizational Project Committee, ACL has identified five areas for focus in the coming year: visibility, membership, professional resources, institute, and governance. Three task forces and two committees are being created to address these areas. Actually, the institute committee already exists but will be given greater focus.

Earlier this year, Amy Wishnick, conducted phone interviews with ten ACL members who represented a wide range of involvement with ACL/JCL/ETC, from former officers to teachers new to the profession. She wrote a summary of her findings. After that ACL made a survey available to its members which touched on similar questions. ACL received over 400 responses to the member survey, from members at all ranges of experience and all levels of teaching. These five areas of focus reflect the responses from these phone interviews and survey responses.

Kathy Elifrits said that the ACL would approve the NJCL By-laws after they are approved at NJCL Convention in late July. Kathy skipped past the budget agenda item as it had already been covered. Treasurer Deb Heaton explained a proposed expense of \$70,000 for a new website platform and design for ACL, NJCL, and ETC using a company called Etchasoft. This proposal had been approved unanimously by both the Executive Committee and the Finance Committee prior to council. It was approved in council as well. Kathy Elifrits appointed a resolutions committee for ACL Institute who basically wittily summarize the proceedings of the institute on the final evening.

Council was adjourned in haste so council members could attend sessions just starting in other buildings on campus.

Prof. Rebecca Benefiel, Krystyn Schmerbeck, Cameron Koon, Meghan Reberman, and Adriene Cunningham learned about wine production at a Minnesota vineyard.

NEH sponsored a three week seminar on Roman Daily Life at Gustavus Adolphus College in Minnesota this summer. Professor Matt Panciera created a three week in-depth look at all aspects of Roman daily life with an emphasis on reading selections from Petronius' *Satyrica* and Pompeian graffiti. Each week Prof. Panciera invited a visiting scholar to help teach the seminar. Professors Beth Severy-Hoven from McCallister College, Jeremy Harnett from Wabash College, and Rebecca Benefiel from Washington and Lee all shared their expertise through engaging lectures and hands on activities dealing with the challenging evidence from Pompeii and Herculaneum. All agreed it was a phenomenal experience.
